Errata

There are inconsistencies between the information shown for 22 South Road and 38 South Road on Maps 1 and 2 of the Great Abington Former Land Settlement Association Estate Neighbourhood Plan that was made (adopted) by South Cambridgeshire District Council in February 2019.

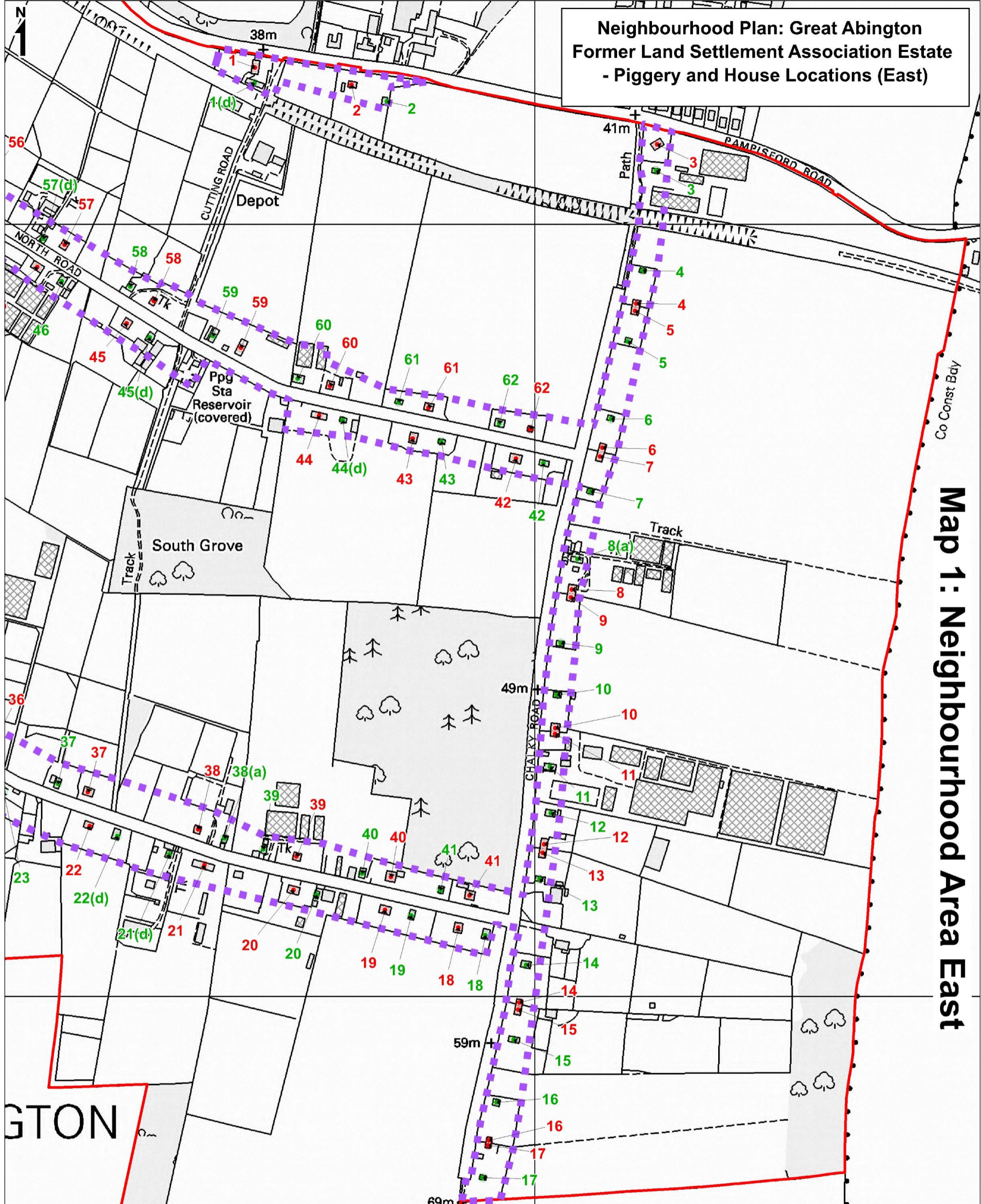
The correct information is as follows:

- **38 South Road:** the label for the site of the piggery should read **38(a)**, as shown on Map 2 of the Great Abington Former Land Settlement Association Estate Neighbourhood Plan.
- **22 South Road:** the western building should be shown as a house with a label of **22**, and the eastern building should be shown as the site of a piggery with a label of **22(d)**, as shown on Map 1 of the Great Abington Former Land Settlement Association Estate Neighbourhood Plan.

Corrected versions of Maps 1 and 2 of the Great Abington Former Land Settlement Association Estate Neighbourhood Plan are included at the end of this document.

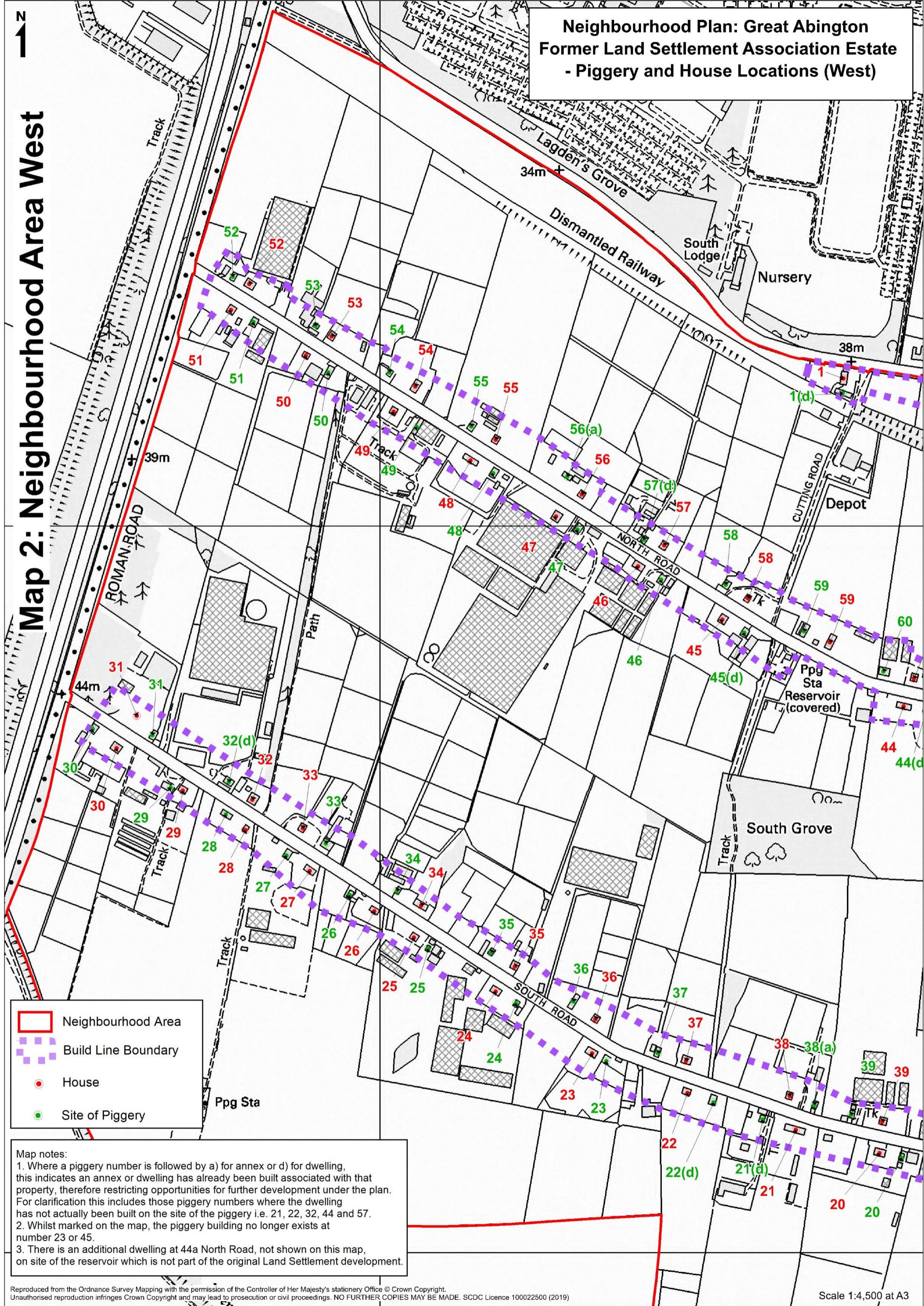
